Dear President Donald Trump,

I am writing to you as a deeply concerned citizen of Romania, a proud member of NATO and the European Union, and a country that has always held the United States of America in high regard. Over decades, the Romanian people have viewed the United States as a beacon of democracy, freedom, and justice—values that have inspired and guided our nation's post-communist path. Today, however, I reach out to you in a moment of profound uncertainty and concern regarding the democratic principles that bind our two nations together.

Romania held its presidential elections at the end of last year, conducted under a two-round electoral system modeled after Western democratic principles. According to this system, if no candidate achieves an outright majority (50% + 1 of valid votes) in the first round, the top two candidates proceed to a runoff. In an unprecedented and deeply troubling turn of events, after the first round, which saw an independent candidate, Mr. Călin Georgescu, advance to the second round, our Constitutional Court intervened during the voting process of the runoff election. This intervention was without precedent, as the Court annulled the entire electoral process mid-vote, citing unverified claims of foreign interference purportedly presented by Romania's intelligence services. These claims were neither substantiated nor subjected to judicial review by any ordinary court of law.

The Constitutional Court's decision to cancel an ongoing election, without providing transparent evidence or adhering to established legal procedures, has left the Romanian people in a state of confusion and disbelief. Many voices within our country have described this act as a "coup," undermining the foundational principles of democracy. To date, no clear explanation or legally grounded justification has been provided to the public, further eroding trust in our institutions and the rule of law.

Mr President, as the leader of the largest and most influential democracy in the world, and as a firm supporter of Romania's condition as a member state of NATO and of the European Union, as a strategic partner of our country, your voice carries immense weight. I am urging you to take note of this alarming situation and to publicly reaffirm the United States' commitment to democratic principles and the rule of law in Romania. This is not a call for interference in Romania's internal affairs, but rather an appeal for a principled stance from the leader of the free world, reinforcing the values that unite us as allies and partners.

Mr. President, your leadership and unwavering commitment to democracy have inspired millions around the globe, including here in Romania. We ask that you lend your voice to this critical moment in our nation's history, reminding the world and our own leaders that democracy must be upheld through transparency, accountability, and respect for the rule of law.

Thank you for your attention to this urgent matter. I remain hopeful that, with your support, Romania will continue to be a steadfast ally and a shining example of democracy in Eastern Europe.
